Enjoy a Safe Holiday Season

The use of candles combined with an increase in the amount of combustible, seasonal decorations in many homes during the holidays, means more risk for fire. The National Fire Protection Association reports that candles cause 46% of fires each December.

- Place candles where they cannot be knocked down or blown over, and out of reach of children.
- Keep matches and lighters up high and out of reach of children in a locked cabinet.
- Use flameless rather than lighted candles near flammable objects.
- Avoid using turkey fryers. The
 Consumer Product Safety Commission
 reports there have been hundreds turkey
 -fryer related fires, burns or other
 injuries, and millions of dollars in
 property loss from these incidents. NSC
 discourages the use of turkey fryers at
 home and urges those who prefer fried
 turkey to seek out professional
 establishments.

Traveling by car during the holidays has the highest fatality rate of any major form of transportation based on fatalities per passenger mile. Alcohol impairment is involved in about a third of these fatalities. Stay safe on the roads over the holidays — and every day:

- Prepare your car for winter and keep an emergency kit with you.
- Get a good night's sleep before departing and avoid drowsy driving.
- Make sure every person in the vehicle is properly buckled up no matter how long or short the distance traveled.
- Put that cell phone away.
- Designate a sober driver to ensure guests make it home safely after a holiday party; alcohol or over-the-counter, prescription and illegal drugs can cause impairment.

Reserve Study and Covenant Updates

The Board of Directors discussed two primary topics at the last board meeting - a reserve study and updating the covenants & restrictions. Community Advisors was selected to prepare a reserve study for review at the board next meeting. This document will estimate the useful life of our roads, bridge, bridge walkway, storm drain system, and monument sign. It will approximate the costs to repair these capital assets and provide a time-line for when they will need repair. Once received, the document will be presented to the community for discussion and feedback.

We will be soliciting input from the community regarding updating the association's governing documents, which are over 30 years old, including what restrictions the community would like to continue to see or eliminate.

Gorilla Group has been conducting inspections under the current restrictions and continues to report boats and trailers stored on property, mold on homes and mailboxes, trash cans stored in view, vehicles and boats parked on the grass, and minor landscaping violations. This is an opportunity to make these documents more reflective of our current community's priorities. Please be on the lookout for correspondence regarding this update.

Included with this newsletter is the Harbour Island Notice of Consent to allow us to send correspondence via email. To help save postage and printing costs related to the covenants update, we are asking all owners to complete the form and mail it back to management.
